



MID SUSSEX TRIATHLON & AQUABIKE RACE PRIVACY POLICY

Mid Sussex Triathlon Club ('the Club') run the annual Mid Sussex Triathlon and Aquabike race. We are committed to ensuring your privacy is protected.

What data we collect

In entering the Mid Sussex Triathlon or Aquabike, the Club collects certain personal information about you which you voluntarily provide to us via our website and online forms.

This will include your name, date of birth, gender, email address, address, telephone number, BTF membership number and the name of any triathlon club you are affiliated to ("Race Data").

Why we collect Race Data and our legal basis

We will process your Race Data under the two lawful areas of consent and contract (i.e. the processing is necessary for the performance of a contract), to administer your involvement in the race.

How we use your information

We may use your Race Data for a number of purposes relating to the event, including:

- Event organisation
- o Communicating race information and instructions
- Processing race forms and payments
- Publishing of race entrants
- Publishing of race and competition results
- Event photography
- With your consent we will sending marketing emails about our race in future years. You may opt out of receiving any marketing communications by following the unsubscribe link in emails.

Sharing your information

We will not share you information without your consent except under the following circumstances:

- our third-party service providers that perform services on our behalf, such as webhosting companies, analytics providers, event hosting services, and information technology providers;
- law enforcement agencies, government authorities or third parties as may be permitted or required by law.

Storage and data security

We will retain your Race Data only for as long as is necessary for the purposes set out in this Privacy Policy and to the extent necessary to comply with our legal obligations.

We implement technical and organisational measures to safeguard and secure the information we collect.
